Common Law: what is Right or Wrong	Statutory ‘Law’: what is Legal or Illegal
Decided by The People (Jury) Uncodified/Procedural/Precedential/Case Law	Enacted by Government (Acts) Codified/Prescribed/Written/Substantive “Law”
Only Common Law upholds JUSTICE Victims are due fair compensation (redress/restitution/restoration)	Crime can exist without a victim Debts must be paid for violations/sins (punishment/spenitence/penitentiary)
Common Laws apply equally to ALL of the People, being created EQUALLY	Statutes are given the “force of law” by the CONSENT of the governed

Record of Live Birth <i>Affidavit of Life</i> for a LIVING MAN/WOMAN , SOVEREIGN MAN/WOMAN , LIVING FACT , EVIDENCE OF LIFE outside the Government	Certificate of Birth <i>Registered Title</i> of an ARTIFICIAL PERSON , CORPORATE STRAWMAN , LEGAL FICTION , TRADENAME created & owned by Government
<i>Sui juris</i> John: Doe is the BENEFICIARY of the TRUSTEE Government by Lawful Right in the EXPRESS TRUST (<i>Cestui Que Vie trust</i>)	Government is the BENEFICIARY and Employer of <i>ens legis</i> TRUSTEE JOHN DOE by Legal Right in the EXPRESS TRUST (<i>Cestui Que Vie trust</i>)
Innate Rights & Freedoms that cannot be taken away (unalienable). <i>All Human Beings are born free and equal in dignity and rights. They are endowed with reason and conscience and should act towards one another in a spirit of brotherhood.</i> Article 1, UDHR 1948	Given Privileges & Benefits that can be taken away (usufruct). <i>Human Being. Monster. A human being by birth, but in some part resembling a lower animal. A monster hath no inheritable blood and cannot be heir to any land.</i> Ballentine's Law Dictionary 1930
Natural Man/Woman Lives in freedom (<i>sua vi suaque sponte</i>) with their AUTOGRAPH	Artificial Person is played by an Actor (<i>actorum sive syndicum</i>) has a SIGNATURE
AUTOGRAPH: The Living Identification, established with a declaration (i.e. 'Authorised Agent', 'By:')	SIGNATURE: A signer is the ' accommodation party ' to the Legal Entity invoking ' joinder ' by consent

Money is innate credit as the value of Human Energy	Money is created as debt as a product of Sweat Equity
A medium of exchange	A commodity per interest
Common issuance of money: Full Reserve Banking, Local Currencies, all interest-free instruments of credit	Monopoly issuance of money: Fractional Reserve Banking, all interest-bearing instruments of debt
Open process of Lawful Contract: Full Disclosure, Valuable Consideration, Lawful Terms & Conditions, Autographs of both parties.	Bank "Loan" is Fraudulent Contract: Banks provide no Valuable Consideration, and practice securitisation without consent.
John: Doe is Secured Party Creditor	JOHN DOE is Liable Debtor
Trade & Contracts are needs-based > fairness > honour > trust > security	Trade & Contracts are profit-based > greed > dishonour > distrust > insecurity
Promotes earned, productive wealth through service	Promotes unearned, unproductive wealth through speculation
Government does not incur debt to fund public services, so less taxation	Government debt increases tax burden until impossible sovereign debt
Economies are unique groups sustained by unique currencies	Unique economies are degraded and subsumed by currency union
Localisation (community building): Complementary currencies, barter, community networks & markets, Fair Trade (equitable)	Globalisation (national disintegration): Currency union, outsourcing, deregulation, 'resource' exploitation, 'Free' Trade (monopolies)
Wealth remains where created in communities and nations	Wealth is transferred upward within and between nations
Promotes equality, social justice, political stability and peace	Increases inequality, social injustice, political unrest and war
Lowers birth-rates in third-world due to improved health and living standards	Causes high birth-rates in third-world due to debt > povety > low health standards
Strengthens ethical government, democratic statute-making, and unbiased media	Leads to the corruption of politics, undemocratic statute-making, and biased media
Less military, more peace-time focus	Builds military and police state
Steady, stable economy without debt-based growth imperative	Perpetual economic growth necessary to service interest-bearing debt
Balanced money supply promotes human and natural stability	Exponential debt drains all human and natural 'resources'
Money circulates like blood	Money bleeds out like blood
Inherently supports Life	Inherently destroys Life
